Legislative update from MOAA National
“Take Action” August 30, 2018

- **Protect Servicemembers from Predatory Lenders**
Send the White House a letter urging the administration to reconsider proposals to relax enforcement of the Military Lending Act.
- **Act now to end the widows tax**
Current federal law requires survivors of deceased military members to forfeit part or all of their Survivor Benefit Plan (SBP) annuity when they are awarded VA Dependency and Indemnity Compensation (DIC). This loss of any portion of the SBP annuity is known as the “widows tax.”
- **Thank a legislator: additional TRICARE fees are off the table.**
A provision in the FY 2019 defense bill was set to raise TRICARE fees for millions of beneficiaries. Thanks to input from MOAA members such as yourself, this proposal was defeated. It will not be included in the final bill.
- **Be Cautious with Compensation Reform**
In a 2015 report, the Military Compensation and Modernization Commission noted modernization might benefit individual compensation programs, but “the overall structure of the current compensation system is

fundamentally sound and does not require sweeping overhaul.” The commission also recommended keeping the basic pay table in its current form and continuing the basic allowances for housing and subsistence (BAH and BAS).

Key Bills

The following are some of the important issues before Congress.

Federal - S 66

A bill to amend title 10, United States Code, to permit certain retired members of the uniformed services who have a service-connected disability to receive both disability compensation from the Department of Veterans Affairs for their disability and either retired pay by reason of their years of military service or Combat-Related Special Compensation, and for other purposes.

MOAA Supports

Federal - S 143

A bill to amend the Internal Revenue Code of 1986 to allow a credit against income tax for amounts paid by a spouse of a member of the Armed Forces for a new State license or certification required by reason of a permanent change in the duty station of such member to another State.

MOAA Supports

Federal - S 339

A bill to amend title 10, United States Code, to repeal the requirement for reduction of survivor annuities under the Survivor Benefit Plan by veterans' dependency and indemnity compensation, and for other purposes.

MOAA Supports

Federal - HR 303

A bill to amend title 10, United States Code, to permit additional retired members of the Armed Forces who have a service-connected disability to receive both disability compensation from the Department of Veterans Affairs for their disability and either retired pay by reason of their years of military service or combat-related special compensation.

MOAA Monitoring

Federal - HR 333

A bill to amend title 10, United States Code, to permit retired members of the Armed Forces who have a service-connected disability rated less than 50 percent to receive concurrent payment of both retired pay and veterans' disability compensation, to extend eligibility for concurrent receipt to chapter 61 disability retirees with less than 20 years of service, and for other purposes.

MOAA Supports

Federal - HR 1384

A bill to amend titles 5, 10, 37, and 38 of the United States Code to ensure that an order to serve on active duty under section 12304a and 12304b of title 10, United States Code, is treated the same as other orders to serve on active duty for determining the eligibility of members of the

uniformed services and veterans for certain benefits and for calculating the deadlines for certain benefits.

MOAA Supports

Federal - HR 93

A bill to amend title 38, United States Code, to provide for increased access to Department of Veterans Affairs medical care for women veterans.

MOAA Supports

Federal - HR 102

A bill to expand the research and education on and delivery of complementary and alternative medicine to veterans, and for other purposes.

MOAA Supports

Federal - S 422 and Federal - HR 299

A bill to amend title 38, United States Code, to clarify presumptions relating to the exposure of certain veterans who served in the vicinity of the Republic of Vietnam, and for other purposes.

Federal - S 2416

A bill to amend titles 5, 10, and 37, United States Code to ensure that an order to serve on active duty under section 12304b of title 10, United States Code, is treated the same as other orders to serve on active duty for determining the eligibility of members of the uniformed services for certain benefits.

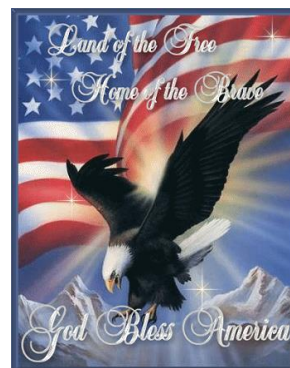

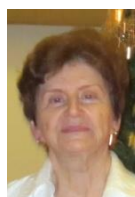

Permanent Early Voting List Information

All voters on the **Permanent Early Voting List** receive an early ballot by mail approximately 27 days prior to any election in which they are eligible to vote.

Getting a ballot early allows time to review the ballot, study the issues, research the candidates and vote conveniently.

All voted early ballots must be received in the office of the County Recorder, other officer in charge of elections, or deposited at any Ballot Center in the county no later than 7:00 p.m. on Election Day.
