Greetings to all:

Just to repeat from a previous article, the family of a veteran receiving retired pay does not receive monies after the death of the retiree except for two instances.

First, if the death was related to military service, there is compensation from the VA. If the retiree was enrolled in the Survivors Benefit Program (SBP) there will be ongoing monthly monies. This is a voluntary program in which a portion of your retired pay is kept in a "fund" and upon the death, a portion of the retired pay continues. Information is available from DoD Finance and Accounting.

Second, it is said that if he lives long enough, a man will die with prostate cancer rather than from it. Prostate cancer is Agent Orange presumptive. If you are diagnosed with the disease (A PSA greater than 4 is getting into suspicious territory) you may be eligible for VA compensation. If diagnosed by a civilian provider, ask to see a VA doctor for a rating physical.

As an unfortunate side note, because of the small number of women who served in the blue water navy or inside the wire, (about 17,000) no diagnostic numbers have been established by the VA and THEY REFUSE TO DO SO, despite pressure from various veterans advocacy groups. I know of several local advocates who are looking at this discrimination and I can give you the names of physicians/attorneys who will represent you if you have been denied. All consultations, exams are free and transportation expenses are reimbursed. As an RN and Vietnam Veteran who spent time in both the field and a field hospital, I know of the hard work women performed and the dangers they endured, just like the men. I urge you to get tested and use the available resources to end this sad process.

LegislativeRitt Schaino



President Donald Trump signed legislation in August that will broaden options for troubled veterans in the legal

system and expand a home renovations grant program for disabled and blind veterans. The new Veteran Treatment Court Coordination Act directs the Justice Department to support the development and establishment of veteran's treatment courts at the state, local and tribal levels. At more than 400 veteran's treatment courts across the U.S., the law will encourage the development of a grant program to expand these courts across all 50 states. With this new law, thousands more veterans across the country facing the criminal justice system will have an alternative to jail time, ensuring they get the treatment they need.

Also, in August the President signed a law that will give more veterans access to VA grants to renovate their homes to accommodate their disabilities. The Ryan Kules and Paul Benne Specially Adaptive Housing Act of 2019 expands the program to include blind veterans and raises the maximum funding veterans can receive from \$83,000 to \$98,000. The bill also will let eligible veterans access the funds six times, instead of three, and gives them access to the full amount every 10 years -- a provision that will let them change residences as their needs change.

taxable - it really was "free" money. Also, if you received unemployment payments, they are taxable like all of your other taxable income. If you did receive unemployment and did not have taxes withheld, I suggest you contact your tax preparer to determine if you should or want to have additional taxes withheld from your other income to avoid a large balance due next April (or whenever Congress decides next year's filing due date).

Thanksgiving in Hong Kong!



In November of 1968, we made a long-awaited trip from Naha AFB, Okinawa to Hong Kong with a group of good friends! I had just returned from a 45-day TDY tour to Ubon, Thailand with a serious handlebar mustache, and Paula and I were ready for some R&R.

The day before the trip, we packed conscientiously to be sure that we were prepared, even down to the "empty" suitcase necessary to bring home all the things we would buy there. The hang-up bag was hung on the back of the bedroom door and our bags were packed with all that we would need. We had dinner with our fellow travelers and celebrated our upcoming departure! Morning came very early and we were in a rush when we left.

We lined up on the ramp with our bags beside us. Check! We arrived in Hong Kong like the tourists we were. That is when it all went sideways! One empty bag? That's all? Not even the hang-up bag? We were stuck...I couldn't wear my uniform in Hong Kong and Paula had one outfit. This is where not being the first of our friends to go to Hong Kong paid off! We pulled out an address, hopped in a cab and arrived at a wonderful place that would provide a suit for me until they could make me one, and all the knit clothing Paula could buy, plus a wrap for evening. She even had shoes made there.

We had dinner at the Hong Kong Peninsula Hotel. More celebration! Thanksgiving was spent on the floating restaurant in Hong Kong harbor after too much celebrating. We had to step into a sampan to reach the restaurant. Steady there! It was a Thanksgiving to remember. The restaurant was rocking back and forth the entire meal with every junk that passed! The most fun I had was waking Paula on Thanksgiving morning with half my handlebar mustache shaved off. It took a while for her to figure out what was different! We found the hang-up bag at home on the back of the bedroom door and the other bag at the airport. All is well that ends well! **Al & Paula Anderer**

Khe Sanh

I arrived in Okinawa at the beginning of July 1966. Paula didn't join me until October of that year. Shortly after my arrival I was headed back to Okinawa from an orientation trip to Thailand (my first to SE Asia) when our aircraft was diverted to Khe Sanh. It was my first landing in SVN and was memorable for what I would later observe.

Khe Sanh wasn't even on the navigator's maps. He had the coordinates but said there were no navigational aids and only a village named Xom Cham or something similar. As we were flying above a cloud deck at about 10,000 feet, the navigator said that it was right below us. A break in the clouds opened, and we dove into the hole and spiraled down. As the sun broke through the clouds, it revealed a lush, beautiful valley with a short runway on the edge of a cliff. After landing, the Marines shared a steak lunch with us while we waited for a bulldozer to be loaded on our aircraft. The steak was cooked over a firepit off one end of the runway. We had a beautiful view of the entire lush valley. It was an uneventful and deceptive introduction to the war zone.

The last time I airdropped cargo at Khe Sanh (which was on the maps by then) in 1968 during Tet, it looked like the moon! Just bare ground with pock marks and no vegetation. After a while, we couldn't land anymore or use low altitude delivery methods, so supplies had to be airdropped just off the end of the runway. I could look out from 600 feet above ground and see the defined perimeter of the base, outlined with bomb craters from B-52s running out from the perimeter for hundreds of yards. Weaving among the craters were lines that apparently were collapsed tunnels that had been heading toward the perimeter. The B-52s put an end to that endeavor. There was an unbelievable change in the scenery around Khe Sanh in less than 2 years – lush to mush! The siege at Khe Sanh lasted 77 days. Disneyland




I was attending a publishing conference in Los Angles in the early 2000s when I worked as a Regional VP for a National Printing Company. I sat down for breakfast next to a lady who turned out to be the Editor of the Disneyland Resort Magazine. She was doing a special about nostalgic events that have happened at Disneyland. So, I told her my story about returning from Viet Nam at the end of the war and our destroyer stopping in San Diego on our way back to Newport, RI.

At that time, Disneyland sold books of tickets (so many tickets were needed for each ride). They gave the ship some books of tickets free. All we had to do was pay for a bus ride to Anaheim. So, a bunch of us went. We rode the rides until we found "It's a Small World" ride. For some reason it just hit us, and we ended up getting off and on the ride about 10 times singing the song as loud as we could. You might think we were drunk, except there is no alcohol in Disneyland. But we had just

spent six months at sea and that ride and song just touched something inside us.

When she heard my story, she said that was exactly what she was looking for and asked me to send it to her via email when I got home I sent her the story, she thanked me but I never heard another word. Then about 2-3 years later, she called me and said they were resurrecting the concept and were doing a special edition on the military. She invited me and my wife to come to Disneyland as guests to take pictures for the article in the magazine. We did and that is what is attached.

In addition, she asked me who my favorite Disney character was. I told her I loved dogs, so probably Pluto. When we arrived, we were treated like royalty and she handed me two pictures. One signed by Pluto addressed to "My Pal, Ritt". The other was me in front of 'It's a Small World' signed by Richard Sherman. He and his brother wrote the song for "It's A Small World" and many of the other famous Disney songs we all know. It just so happened he was there when the magazine came out, to celebrate the 50th anniversary of "It's A Small World" and she had him sign it for me. What a thrill. **Ritt Schaino**





Our time in the Philippines



In our three-year assignment in the Philippines the first year stood out for the entire family. During 1989 there was a lot going on in the country and Clark Air Base; civil unrest, economic uncertainty, communists trying to take over the government, and the increasing uncertainty of the continued existence of Clark AB and the Naval base in Subic. For our first year we had to live off base. Both on base and off base you were always susceptible to theft of your property, just as Clark AB had a large problem with theft of government property. Our first year was what left the greatest impression on us. There was a wall around the base that we jokingly referred to as 'The great wall of Clark'. Locals would scale the wall in flip flops and get around security.

Our story starts with Ed, my 15-year-old son, 12-year-old daughter, and me arriving at Clark AB to have my kids get chicken pox while we were in the TLQ. The home we rented was about two miles

from the base in a compound guarded by Philippine guards 24/7. Military personnel were targets for the communist guerrillas, so Ed wore civilian clothes to the base and then changed into his uniform. When there were base lockdowns (and there were a lot because of the many government coup attempts), Ed had to stay on base while we were at home. While we were stationed at Clark a service member paid a local \$100.00 to kill his wife. This was an environment we had never encountered before.

On a good note, we had a house girl and yard boy. It was nice and different, but we really had no choice because if you didn't 'play the game' and hire these people, your home would probably be robbed. Our daytime house girl was a wonderful lady that was older than me and I had a hard time being home and watching her do my work. So, I volunteered at the OWC gift shop and played tennis. I did enjoy listening to her tell me about her life in the Philippines.

One evening we couldn't find our daughter. She had gone to visit a friend in the compound earlier but was not home when we expected (this was before cell phones for everyone). We panicked, looking for her for about 5 hours when we finally found her at another friend's house. This other friend had been upset and she was trying to help her. I mention this because of the environment were living in. After she got off restriction this never happened again!

The kids attended school on base and often stayed there after school for extra-curricular activities. Ed worked odd hours and I usually drove to the base to pick up the kids. One afternoon my daughter and I were driving to the base to pick up my son. We had just gone over Friendship Bridge when we heard gun fire. As we looked back, the communist guerrillas and Philippine military were exchanging gun fire across the bridge we had just driven over.

Thinking of her kids, my daughter remarked the other day, that she wonders how many American kids remember being at school and seeing military police in Humvees patrolling around the school with machine guns.

After a year we moved on base and that was a relief. Most non-military jobs on base were manned by Philippine locals and they couldn't get on base during the base lockdowns. During one of these lockdowns, I along with other officers' wives volunteered to waitress at the officer's club so the pilots that were TDY there would have a place to eat. My daughter and other dependents volunteered to bus tables.

In July 1990 there was a 7.8 earthquake centered about 70 miles from base. My daughter was on a carnival ride in the BX parking lot. The local running the rides got scared and ran away leaving everyone spinning out of control. My son ran over and turned off the ride. The earthquake was not like the ones we had experienced in California. A rolling earthquake, it lasted several minutes. Cars were bouncing around in the parking lot.

After the earthquake, Mt. Pinatubo, a volcano which had been dormant for 500 years became active again. Officers housing was seven miles from the volcano. For a year there was a smell like sulfur in the air, and we periodically would see steam and ash over the volcano from our house. Then, came small eruptions, and in June of 1991 everyone on base was evacuated to Subic Bay as they expected a full eruption. The evacuation was impressive. Ed had orders for his next assignment, so our car and household goods had already been sent away. We, two kids, two adults, and two dogs, caravanned to Subic in a six pack. We slept in the pickup the first night and then stayed with a nice Navy family for two days. As we were boarding the plane to leave a large eruption caused a plume of ash to enter the air space. Ours was the last plane to leave before the large eruption. Mt. Pinatubo's biggest eruption was two days later.

My son was graduating high school. He never got to have the ceremony; his diploma was mailed to us at our next duty station.

I wanted to share this story from the families perspective to remind everyone that when a service member has a family, everyone is in the service with them and we never know what challenges we can handle until we are faced with them. An Autobiography of 1LT Gregory Moore, USA, Retired





I was born in Quincy III and raised in Palmyra Mo., a small farming community 18 miles from Quincy and 11 miles from Hannibal Mo, home of Mark Twain. My father was a schoolteacher and my mother a cosmetologist. I have a sister in Tucson who is a teacher, a part time goldminer in Canada and plays volleyball at a national level.

The summer of my sophomore year we moved to Payson Arizona. I graduated from Phoenix HS in 1964. Attending Arizona State University, I majored in education (history/chemistry). I joined ROTC, where I met fellow chapter member Karl Pfitzer. Our class graduated in 1968.

I was commissioned a 2LT Infantry and attended my basic school at Ft Benning Ga. I was next assigned to an AIT training Bn at Ft McClellan Ala. From there I attended Jungle School in Panama and then was sent to Vietnam to be with the 1st Infantry Division, the "Big Red One." (If you are going to be one, be a Big Red One), as the saying goes. I served as an infantry platoon leader until June of 1969 when I was wounded in a combat action.

Nine months later I was discharged from the hospital in Texas and returned to Arizona to attend graduate school majoring in Counseling. While in the hospital I was retired from the army as a 1LT. I was still going to school when I was recruited to coordinate a federally funded program to assist veterans/active duty who had a background in military healthcare and assist their transition into the civilian work force.

During this time, I was selected by the DAV as Arizona Employee of the Year and also the Arizona Disabled Veteran of the Year. I started the Arizona Hospital Association's nurse recruitment program. I left the Association and enrolled in the College of Nursing at ASU graduating with a BSN. I have been an RN for 30 years and have held national certifications in Medical Surgical and Oncology. My primary specialty is home care and have 20 years of experience as a Case Manager/visit nurse.

I am a charter member of SMC/MOAA and have been Personal Affairs officer for the last six years. I also belong to the VFW, DAV and VVA. Outside interests include martial arts (Yang style Tai Chi) and reading.)

Meredith and I have been married 27 years (no children) and enjoy traveling on small ship river cruises and visiting family, especially the elementary school aged nephews in Santa Fe
