We are pleased to announce this progress report on the formation of your TROA Chapter. Over 230 local members of the National Organization responded to our initial letter, indicating an interest in joining. The first organizational meeting held on November 20th was attended by 135 enthusiastic retired officers and spouses.

The organizing and nominating committees have met three times and have completed their recommendations for presentation at the second organizational meeting on January 8, 1975. (The committees used recommended guidelines contained in the TROA Chapter Handbook.)
