President's Comments Col. Robert Grierson

September greetings to the Superstition Mountain Chapter. This month's column will focus on the recruiting problem faced in today's military.

We are nearing 50 years of the "All Volunteer Force" following the end of the Viet Nam War. In that time, our servicemen and women have been sent to numerous garden spots throughout the world, and we've lost thousands of our sons and daughters in defense of our Nation and its principles. But never have we faced such difficulty in recruiting and retaining service members.

From an economic perspective, it makes sense for a military pilot with 10 years in uniform, earning \$90,000 per year to jump at a chance to fly for the airlines, earning several hundred thousand more. And if you're 17 years old, earning \$16 per hour at Burger King may seem more fiscally sound than \$1774 per month as an E1. Although, working at Burger King really doesn't come with any benefits other than the occasion Whopper. Aside from learning how to deal with other employees and an irate customer, no real job skills are learned.

DoD has often reported that 80% of American youth are ineligible to join the military. I question that number. It's one thing to be disabled or a criminal, but another if you are just lazy, fat, or stupid. When I was a young enlisted man, we placed our less intelligent personnel into jobs which required less skills. We also had fat farms where diet and exercise were stressed and monitored.

Recently, the Army has created a program to accept candidates who want to serve, but who failed the physical or educational standards. They put them through a rigorous process to bring up their scores to meet the standard. (cont'd)

It's been an overwhelming success. For more than 20 years, the National Guard has run the Challenge program, working with "at risk youth", teaching them discipline, self-reliance, and helping them to obtain their GED. Many of those who graduate join the Army National Guard.

We have many ways to address the recruiting problem. My bigger concern is not the lack of awareness of what the military has to offer; rather it is the indifference of our youth to serving their country. Recent surveys have shown a dramatic decline in patriotism. If you believe that your country is racist, sexist, and led by evil people, why would you want to serve or defend it?

I would say that each of us was raised with a different view of America. However, we believed, and still believe, that we are not only the greatest country in the world, but that America is the last bastion of freedom in the world. So, how do we best impart our beliefs and values to Gen Z?

Please Talk to your grandchildren; talk to kids in your neighborhood. Join a local speakers bureau and speak to Rotary, Kiwanis, Lions, and other local clubs in your community. Fly the flag regularly. Talk about your experiences in the military. It wasn't all miserable. It was fun, exciting, boring, and exhausting – all at the same time. We never felt more alive! Shortly before I retired from the Army reserve in 2017, I administered the oath of enlistment to a group of young men and women. I hope that they had as much fun in their service as I did.

While Burger King wants to employ our youth, our Nation needs them. There's quite a difference between the two.

Greetings to the Superstition Mountain Chapter. At the time of writing this column, our erstwhile

legislators are on break this month.

At the Federal level:

While conventional wisdom holds that your wallet is safe when the legislature is out of session, that doesn't hold true for many of the bills currently in limbo. Important bills like the MAJ Richard Star act HR 1282, or the Guard VA Benefits Act HR 1139, the BAH Restoration Act HR 2537 all affect pay and benefits for many of our members. In most cases, the votes are there. But these bills are stuck in either committee or lack of leadership in either chamber.

One of the great benefits of being a MOAA member is the legislative advocacy we have in DC. MOAA has a full-time team dedicated to protecting and expanding the benefits for all servicemembers. But they need your help. This year I've met with Reps Biggs, Stanton, and Gosar and found them to be interested in helping but lacking the knowledge of various bills. The common question I keep hearing "is this needed?" What this tells me is we need to fill their inbox. They don't use mail any longer. Letters are diverted to a handling facility. Email or phone calls are what it takes to let them know what you support. Always have the bill number handy (HR 1282 and S 344 for the Star act). Tell them you are their constituent and to support the bills.

Did you know that you can send emails to all your representatives at the federal level just by using the MOAA.ORG website? Just follow these steps:

- 1. Go to MOAA.org
- 2. Click on "Advocacy"
- 3. Click on "Legislative Action Center"
- 4. Click on red box in upper right "Sign Up"
- 5. Fill out the information required and submit

To make this more efficient for you, please register with MOAA Legislative Action Center by doing the following:

- 1. Go to MOAA.org
- 2. Login to your MOAA account
- 3. Click on "Advocacy"

5. Under "Active Legislative Campaigns" Click on an issue or "Write" (in a black box) to the right of the issue you want to write about

- 6. When you click "Write" the next screen will be populated with letters to both our Senators and to your Representative.
- 7. Note: You can edit the proposed letters if desired/needed
- 8. Scroll to the bottom and click on "Submit Selected Letters"


9. That's it!

Resident applications OPEN at ASVH-Flagstaff!

The Arizona Department of Veterans' Services (ADVS) is happy to announce that we are accepting admission applications to the Arizona State Veteran Home-Flagstaff (ASVH-Flagstaff)!

The new ASVH-Flagstaff sits on 10 acres of land donated by the City of Flagstaff. Nestled in the ponderosa pines, the 74,000 square foot skilled-nursing facility will have 80 beds serving the long-term care and rehabilitative needs of Veterans and their families. The home provides

furnished and private resident rooms equipped and designed for all mobility levels in a homelike atmosphere. (cont'd)

"We are grateful to the Flagstaff community for their continued support throughout this entire process," said Deputy Director of Arizona State Veteran Homes, Kim Trotta. "It has been a long road, but we are so excited and thrilled to start accepting applications and welcoming residents."

Those eligible for admission are Veterans (with an other than dishonorable discharge), a spouse of a Veteran, or a Gold Star family member.

All applicants must meet eligibility requirements and submit a completed application with all required documents to be considered for admission. Failure to submit a completed application will result in a delay in the processing of your application.

ADVS broke ground on ASVH-Flagstaff in 2019 after the U.S. Department of Veterans Affairs State Home Construction Grant Program approved establishment costs for the new facility. The grant covers 65% of construction costs, with the State securing matching funds.
